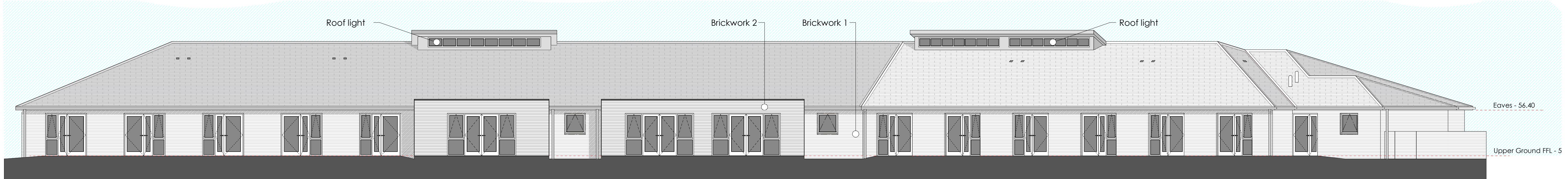




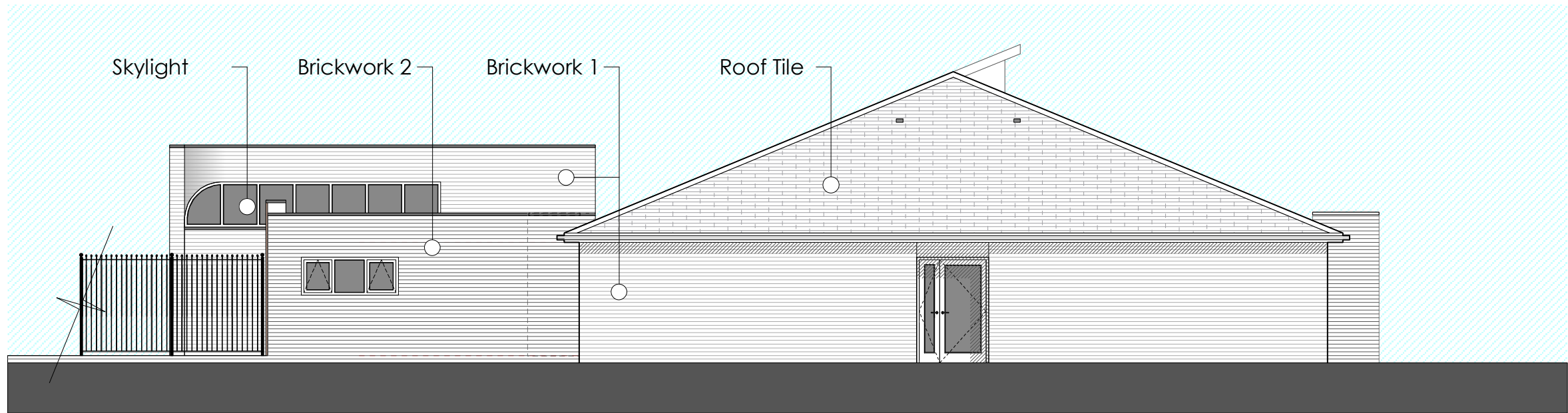
Elevation 1



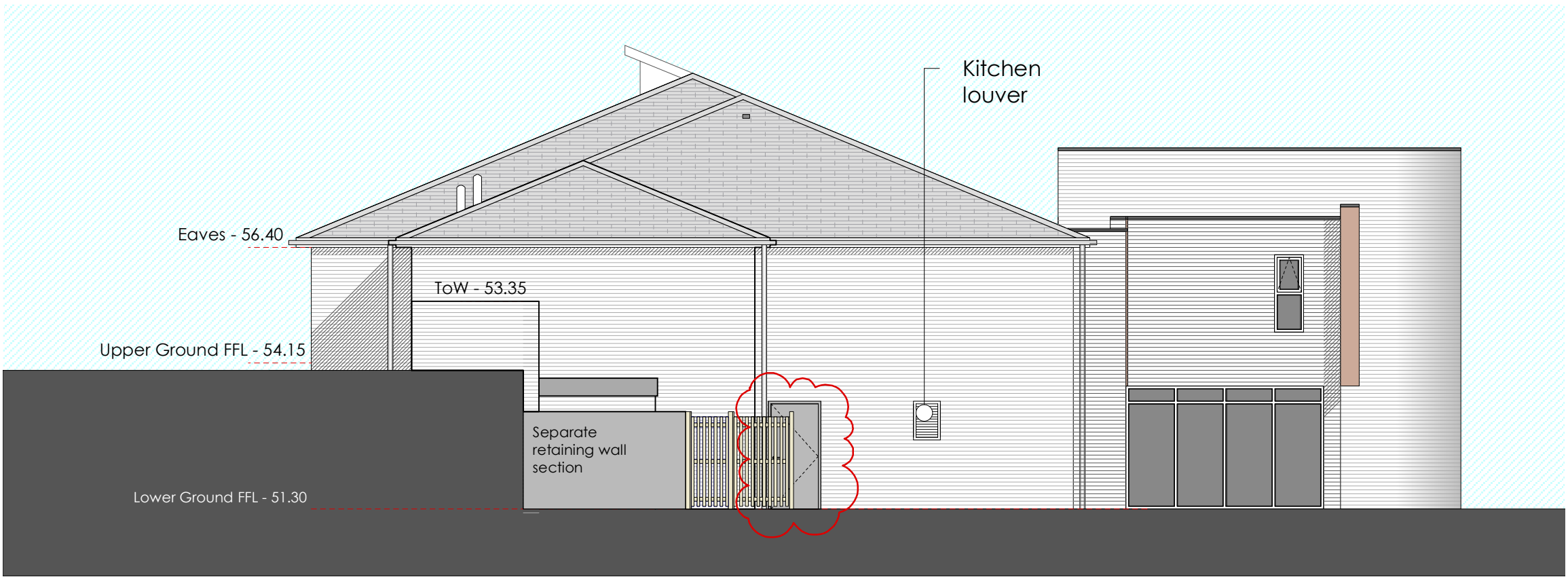

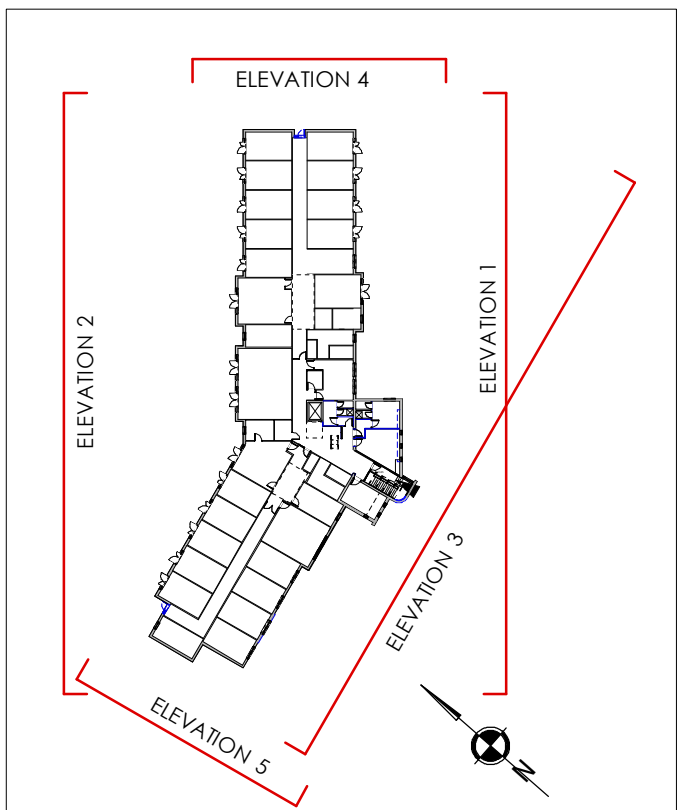
