



Material Legend:

- ① Curtain walling, powder coated frames, dark grey. Neutral tint glazing.

② Brushed metal rainscreen cladding panels, bronze or similar approved.

③ Glazed balcony, fixed directly to curtain walling system.

④ Feature frame - powder coated aluminium, dark grey.

⑤ Red mix brick. Finish and texture to be confirmed.

⑥ Feature brick detail expressing vertical nib.

⑦ Lift over run. Aluminium powder coated cassette panel, mid grey.
- ⑧ Feature frame to windows. Brush metal cladding to match feature cladding panels.

⑨ Brick 'frame' detail to provide prominence to vertical curtain walling.

⑩ Grey brick stock. Finish and texture to be confirmed.

⑪ Windows/external doors, powder coated frames, dark grey. Neutral tint glazing.

⑫ Feature frame to windows. Powder coated aluminium, dark grey.

⑬ Curtain walling, powder coated frames, dark grey. Neutral tint glazing.
- ⑭ Brushed metal rainscreen cladding panels, bronze or similar approved. Framing provided above windows and to designate unit demises.

⑮ Glazed balustrading.

⑯ Dark grey brick infill panels. Finish and texture to be confirmed.

⑰ Metal balustrades, powder coated, dark grey.

⑱ Roller shutter to secure under croft parking. Powder coated, mid grey.

⑲ Feature brick panel with constrating bond/profile. Dark grey, mix and texture to be confirmed.
- ⑳ Vertical recess detail to brick

㉑ Feature powder coated aluminum frame detail and window unit, offset from facing brick to head, left jamb and cill. Flush with brick work to right jamb with shadow detail.

㉒ Horizontal louvres with integral doors. Power coated, dark grey.

㉓ Undercroft
