

## Material Legend:

- Powder coated windows within recessed vertical bay. Brick panels to head/cill of intermediate units. Powder coated aluminium reveal to head, jambs and forming cill. Colour dark grey to match frames. Neutral tint glazing.
- 2 Rainscreen cladding panels; powder coated dark grey or similar approved
- 3 Powder coated balustrades/handrails to balconcies, fixed directly to window units within standard recess detail.
- 4 Red mix brick. Finish and texture to be <sup>r</sup> confirmed
- **5** Buff brick stock. Finish and texture to be confirmed
- 6 Projecting brick profile to frame window recess.
- (7) Windows/external doors, powder coated frames, dark grey. Netural tint glazing. All units recessed min of 150mm from facing brick/rainscreen cladding . Set of all window units standardised with powder coated reveal 13 Recessed drop shadow detail detail.
- (8) Dark Grey rain water pipes / goods. When adjacent to brick these will be located within vertical reveal detail.

DRAWING NOTES:

- **9** Roller shutter to secure under croft <sup>9</sup> parking. Powder coated, mid grey
- (10) Horizontal louvres with integral doors. Power coated, dark grey
- (11) Undercroft
- (12) Glazed balconcies
- (14) Recessed brick bays
- (15) Brick detail panel vertically laid brick in stack bond formation. Design intent for crisp and contemporary detailing to emphasis brick material(s).


