Condition 8:  
Prior to its installation, details of a fume extraction system to be installed to all areas where hot food is to be prepared shall be submitted to and approved in writing by the local planning authority. The fume extraction system shall be installed in accordance with the approved details and completed to the satisfaction of the local planning authority before the development is brought in to use. Extract ducts shall be acoustically insulated and acoustically isolated from associated fans and the building structure. The discharge point should be at least 1 metre above roof eaves or in another such position so as to minimise the likelihood of nuisance to neighbouring premises.

Condition 29:  
Prior to the commencement of development, full details of a phasing plan demonstrating 4 phases, that has been provided in a diagrammatic form as part of the planning application, shall be submitted to and agreed in writing by the Local Planning Authority. For the avoidance of doubt this shall include details of all buildings, vegetation, areas of hard standing and ancillary works.
