Removal of 3 trees (2 sycamore, 1 Elm), works to 1 Copper Beech tree (remove secondary branch approximately 75mm in diameter over property @ 7m to the second bifurcation, Remove 2m stub @6m, Remove crossing lateral in property side @ 8m), and replacement planting of 5 No. trees.
