Move an existing canopy to the other end of the site and build a single storey conventional best match brick (buff multi) building extension approximately 48m2 on plan at the east end of the existing building. It will be fitted with a mono pitched lean-to corrugated steel composite panel plastisol coated roof (RAL7046 to match the existing roof and high wall cladding). Fenestration will match the existing aluminium profile windows and be powder coated RAL7035. Surface mounted security shutters will be fitted to doors and windows, with a powder coated finish of RAL7046.
