Hi Janine

I have received some feedback from our aircraft partners who are happy that the wind turbine is far enough away from the landing site at Aintree not to represent a significant hazard but it will sit on the ENE approach. In respect of this they have requested that the turbine be equipped with low intensity steady (generically 32 candela) obstruction beacon, as near to the top as possible, seen from all directions.

Hope this information is suitable. We do work with a company who provides us with obstruction lights for our projects who we recommend so if you would like their contact details please do not hesitate to contact me.

I work for Arcus Consulting and are assisting United Utilities to meet the conditions of the planning permission that was issued by Liverpool City Council in December 2014 for a 78 m high turbine in Fazakerley (Planning Permission No. 14F/1296). Condition 19 of the planning permission states:

The wind turbine shall not be illuminated by lighting other than service lighting required under safety requirements for tall structures and any air safety lighting required by other authorities or bodies, without prior written approval of the Local Planning Authority.
