#### **Condition 3**

Details of materials for the footways around the new Main Stand and public realm areas are provided on the submitted plans, in particular Hardworks General Arrangement Plan ref PL1312.GA.108.

The materials have been previously reviewed and agreed as acceptable in the section 73 application and at site meetings in June 2015. Specific samples are not therefore now being submitted; however should any further review of materials be required by officers, please do not hesitate to contact me and arrangements can be made for this.

#### **Condition 4**

Details are provided of:

- the landscaping proposals to the public realm areas (Softworks General Arrangement Plan a ref PL1312.GA.109), all planting areas including species, height and spacing of planting (refs GA201/202/208), tree pit details (PL1312.D.406/407/408) and tree soil plan (PL1312.GA.200). Specific extract plans for the planting of areas to Alroy Road, the Memorial Gardens and the OB area are also provided (PL1312.GA.203-206).
- proposed surface materials for areas of hard landscaping as above, details are provided on the Hardworks General Arrangement Plan (PL1312.GA.108), and detailed plans for retaining and plinth walls; edgings, and the Memorial Garden area surfaces.
- maintenance plans for the hardstanding surfaces and the softworks landscaping areas (reports).
- provisions have also been made within the scheme materials selection and layout/ maintenance proposals for security of the landscaped areas to prevent anti-social behaviour as detailed in the supporting note.

#### **Condition 18**

Details of street furniture are provided on the general arrangement furniture plan PL1312.GA.124 and more detailed plans for seating/ benches; bollards; knee rails and balustrades.

The siting of features and the access/ levels arrangements around the site enables inclusive access to seating and other information/ landscaping areas.
