- \*\* Countryside construct all of our properties in timber frame construction with the intermediate floors being clear spanning; as a result, all of the internal walls are non-loadbearing and can be removed / re-positioned as required by any future occupants. This means that the only fixed elements within each property are the external openings and drainage penetrations through the ground floor slab. The flexibility inherent in this allows the proposed housetypes to be constructed as per the submitted plans.
- \*\*\* All ground floor sanitaryware is drained via a direct drainage connection, as such these are suitable for an "accessible floor level shower".
