This is probably a once in a lifetime opportunity to bring much needed new investment and jobs to the area

This is an opportunity and vision that cannot be missed. It will be a milestone in the history of this city which will bring untold opportunity and investment to us all as a city, regardless of the Football team we follow

I really approve of the changes made to the plans for Everton's proposed stadium at Bramley-Moore Dock aesthetically and also helping with disabled access to the stadium

The council has to approve planning permission for Everton football clubs new Stadium at Bramley Moore Dock. The design not only looks spectacular, but it is what the North end of Liverpool has needed for years. That's investment and the opportunity for the area to be transformed, also the jobs created locally with the construction phase and running of this first-class arena that the city should be proud of

The West Stand looks great with the stepped plaza now added. However, it

looks like the access along the sides of the north and south stands to get out from the west stand are going to be large bottle necks as the stadium empty's post match.

The stadium will underpin a transformational regeneration of the sub region, the scale of which goes beyond the north docks. The scheme also transcends football allegiances, as the proactive consultation by the Club has resulted in unanimous and extensive community support. Everyone recognized the benefits that this project can bring.

In all my years working within the development industry, I have never known such a complex and huge scale proposal to have generated such a uniform and positive response.

With the post covid era needing something to give people hope for the future, I can't think of anything better than this project.

Everton FC have bent over backwards to appease the heritage concerns. The site has laid derelict for many years and without this significant investment this area will probably be derelict for many more years.

Have reservations about the stepped plaza on the river side with the angled brick wind break and the configuration of the internal seating as the seated "bowl" doesn't stands out any different from any other stadium.

Cruise ships from around the world will not see a dilapidated and unused dock from the 1800's but will see a world famous football clubs 21st century stadium greeting traveler's as they sail down the river Mersey.

The new stadium will show the world that the city of Liverpool is not just living on past glories but pushing ahead into the future

if this application is not approved, then we will see a decline of the area that will continue for many years to come

It would be catastrophic to our future if this is delayed. This must NOT be slowed down in any way

The first plans were absolutely outstanding yet the changes have actually made the stadium even better.

Support the location and design of this project 100% - the benefits it will bring to the area far outweigh any perceived negative impact. Historic England and the Victorian Society are doing the City a grave disservice by trying to delay the building of this stadium. The former are trying to protect a dock which is not even open to the public and whose historical features, including the clock-tower, will be preserved and even enhanced.

The development will provide a world class stadia for football and other events and will be a complete asset to the Liverpool waterfront

The stadium is essential for Liverpool's future growth and prosperity especially given the devastating impact of COVID 19. It will revitalize the city again and create many jobs like the Albert Dock did for this city.

Shame on Historic England, like their name suggests stuck in the dark ages and against progress and common-sense

The capacity should be greater than proposed due to the huge demand for tickets and the already sizeable waiting list for season tickets

EFC have clearly listened to the concerns of the various interested parties and amended their plans to reduce and or address such concerns. In a situation like this not everyone can be happy but the larger picture must always win out.

The whole regeneration of the area in North Liverpool docks is simply a must for the city and wider region. Having worked at the far end in Bootle docks and now near Sandhills and regeneration all the way up to town is badly needed.

Madness to not want this to happen. I for one couldn't care less if one of the old docks is filled and I'm a Liverpool fan.

I do not understand how these so called heritage agencies and others oppose the plans. They appear to be quite willing to let these areas continue to decay and rot at a time when ever job and investment should be welcomed.

Everton have been open and willing to adapt to changes raised by Historic England and I believe the new designs to be an improvement on an already brilliant project.

The site is derelict and the surrounding area have been in need of significant investment and redevelopment for some considerable time

This project is so vital for the regeneration of the surrounding area and there can be no objection to the benefit it will have to the local economy.

This project will be the lifeblood for the North end of the city for decades to come. The design is fully sympathetic to history of the site which is presently no more than an eyesore attracting no person to the area in terms of visiting or investment. The thought of rejection is totally incomprehensible and beyond belief.

There is a story to be told and what better way to engage people's interest than through a project like this...no one is coming to visit Bramley Moore Dock as is, it would be great to reinvigorate interest in the area. It is imperative that this project is allowed to proceed without unnecessary delay

The stadium build will be the catalyst for further redevelopment of the North dock area and surrounding streets, which would rival the success of the Baltic Market area regeneration.

I greatly support the amendments made to the original design submitted, it is more suitable for pedestrians and increases access to the water front

Historic England believe it should be called in unless it can be proven that the future positivity outweighs the tradition. The stadium plans has revealed the number of jobs this will create, the expected income this will provide, and how it will kick start a redevelopment of an area where it is very much needed.

This stadium looked incredible before now looks even better with adjustments, the main aspect for me regarding this, is that it breathes life into a derelict run down part of the city and benefits the area and wider region in so many ways whilst preserving a lot of the features like the dock walls and restoring the hydraulic tower

which is great vision and consideration by the club to respect the heritage of the area.

The plans don't provide sufficient parking/motorbike storage

This is a once in a lifetime opportunity for such a development on this scale. It has to happen.

The changes have enhanced the design

The updates improve what was already an impressive design. Particularly feel the plaza steps and removal of the multi storey car park from the west side significantly enhance the stadiums aesthetic appeal. The new designs make the stadium merge more smoothly into the dockland settings.

The shortsightedness and the willingness to let an area remain in a state of dereliction from Historic England is criminal and an example of bureaucracy gone mad. Even without a global pandemic destroying the economy this stadium will provide so much for the people of our city, both red and blue. But with the challenges that face the country as whole to get back on our feet when the pandemic passes, this project is even more vital to the survival of our city and the creation of local jobs.

The new stadium on this site I believe will act as a much needed catalyst for redevelopment in Northern Liverpool on a site which is currently derelict and inaccessible to the general public.

Scheme will increase traffic and reduce air quality

The stadium will transform the north docks area and will bring massive social and economic benefits to the city. With the currently pandemic ongoing for the foreseeable future, it would be folly to pass up such an opportunity to regenerate the area, create thousands of jobs and bring millions of pounds worth of investment to the local and national economy.

English Heritage have opposed this on grounds of heritage principle and UNESCO guidelines but their suggestion that the site has viable alternative uses including housing is totally at odds with the reality. No other viable plan exists for this site or has existed in recent decades and not a single house has been built. It is a classic example of sophistry designed to disguise the fact that in opposing this development they know they are blocking regeneration and economic development of the area for the foreseeable future. Football is literally the only game in town for this site.

Any other proposals only have outline planning permission and they're decades off, if they even happen at all. No apartments are going to be built by a sewage works, Historic England have to be realistic. The dock will be preserved, old building and fittings, cobbles, tram lines, the lot. This site will bring in so many jobs if this goes ahead or will lie derelict, walled off from the public forever, if Historic England and UNESCO get their way, please approve for the sake of the city.

This is vital for the North End of Liverpool which is in desperate need of jobs and regeneration. I live in Kirkdale and this has the potential to provide a welcome kick start for the area and the people who live here. As someone who is looking for work struggling to feed my family after losing my job due to covid, if the city chooses some poxy heritage title instead of making a logical choice that will benefit the people of Liverpool it will really be a kicker.

I believe the changes made to the application have significantly improved the proposals sustainability, visual aesthetics and public realm offering. The development would also be of considerable benefit to the wider area that is in

dire need of investment and regeneration. This once in a lifetime opportunity to inject much needed capital and jobs in the city of Liverpool cannot be passed up.

The recent amendments to the plans look so much better especially the stadium height it's important for the stadium to be in proportion to its surroundings and the steps give it a more European appeal looks great so much potential to create jobs and future for that part of the city as well as investment opportunities which is greatly needed after this terrible time were enduring

Historic England's objections are ridiculous. The preservation of history is important. But the preservation of history at the expense of the people who actually live in the area does more harm than good. The people of Liverpool are not going to forget their proud maritime tradition because one derelict dock on a vast expanse of derelict dockland was converted into something that actually brings a benefit to the local community. As it stands, the vast majority of the public ignore Bramley-Moore Dock. Thousands of Liverpudlians drive past it every day without giving it a second glance. The new Stadium would keep attention on Liverpool's historic docklands. It would preserve their memory, and tie them to a fundamental part of this city's community, and identity.

As a resident, I cannot go and walk around Bramley Moore. I cannot get any benefit at all from the site. If the new stadium is built then I can access the site and can actually see things like the pump house which Everton have promised to incorporate as part of the new stadium

A riverside football stadium is an amazing once in multiple generations opportunity. If ever an area needed a rocket boost to aide development this is the area and this is the boost. There will be endless secondary and tertiary benefits and developments to come from this and the area would be forever changed for the good.

The benefits are there for all too see, jobs, regeneration, taxes back to the council etc. This will not only give a bit of Liverpool back to the city that's been closed off for a generation, it will look beautiful too.

Totally impressed with the planning application and the thought that's went into. At every point, the heritage bodies and the public have been involved and it's ticked every box. Everton have went the extra mile to preserve the dock and landmarks, and in the case of the latter, are crumbling and have a bleak future without intervention.

This site will bring in so many jobs if this goes ahead or will lie derelict, walled off from the public forever, if Historic England and UNESCO get their way, it's a no brainer, please approve for the sake of the city.

The new stadium development at the North end of the City will lead to massive further investment thus making the whole of the Liverpool water front become just as attractive to developers that the South end is. It is a win / win for the whole of Merseyside allowing the investment to spread to the wider area.

Whilst heritage concerns about the filling in of the dock at Bramley Moore, are justified but surely having a derelict dock which if this proposal gets turned down will probably not be redeveloped for at least another 20 years.

Fully support the amendments my only disappointment is the length of time it is taking to make a decision on planning permission and the disappointment why English Heritage are trying to stop a fantastic project like this to enhance and improve the heritage of that area which is currently sitting derelict which has been for many years.

These new updates have actually enhanced the original proposals and therefore I would like Liverpool City Council to pass this application as soon as possible. The stadium will be magnificent and will only improve the area, create jobs and create new communities.

The amendments enhance the stadium, particularly the stepped plaza and removal of the car park. This will greatly improve the look of the stadium from the river and I fully back the design changes and this planning application

The increase in the public benefits that could be delivered by a proposed new stadium at Bramley-Moore Dock (which is currently an un-used, derelict site, behind locked gates) as well as a community-led legacy development at Goodison Park are a must for this city, to help provide economic growth, particularly in the current/post COVID 19 climate.

The stadium needs to go ahead for the sake of the region. Jobs need to be created.
